## PM Modi urges all parties to back Women's Reservation Bill for implementation before 2029 polls

New Delhi, April 12 : Prime Minister Narendra Modi has written to floor leaders of all parties in both the Lok Sabha and the Rajya Sabha, seeking their support for the unanimous passage of the Nari Shakti Vandan Adhiniyam to ensure the implementation ahead of the 2029 elections.

In his communication, the Prime Minister emphasised the importance of passing the legislation, which provides for one-third reservation for women in legislative bodies, during the upcoming special session of Parliament scheduled to begin on April 16. He described it as a significant milestone for strengthening democratic values. A Special Session has been convened next week



to deliberate on and pass the Women's Reservation (Amendment) Bill. In his letter, PM Modi wrote, "From April 16, a historic discussion related to the Nari Shakti Vandan Adhiniyam is set to take place in Parliament. This special sitting is an opportunity to further strengthen our democracy. It is also a moment to reiterate our collective commitment to moving forward

together, taking everyone along. I am writing this letter to you with this spirit and purpose." Highlighting the role of women in nation-building, he stated, "Any society progresses only when women have the opportunity to progress, make decisions and, more importantly, to lead. For India to realise its vision of becoming a developed (Contd. on pg.2)

Washington, April 12 : US President Donald Trump was closely involved in high-stakes nuclear talks with Iran and has backed a "final and best offer" to Tehran after negotiations in Islamabad collapsed without agreement, Vice President JD Vance said. "We leave here with a very simple proposal, a method of understanding that is our final and best offer. We'll see if the Iranians accept it," Vance told reporters after 21 hours of negotiations. The Vice President underscored Trump's direct role in the talks, describing constant communication between the negotiating team and the White House. "We were talking to the president consistently. I don't know how many times we talked to him. A half dozen times, a dozen times over the past 21 hours," Vance said. He said the President had instructed negotiators to pursue a deal in good faith but with clear limits. "The president told us, you need to come here in good faith and make your best effort to get a deal. We did that," Vance said. ## BJP issues whip for MPs ahead of 3-day special Parliament session from April 16



New Delhi, April 12 : The BJP has issued a strict three-line whip to all its Members of Parliament in the Lok Sabha and Rajya Sabha, directing them to remain present in the House continuously from April 16 to April 18, amid the upcoming special sitting of Parliament. In an official notice signed by Office Secretary Shiv Shakti Nath Bakshi, the party stated: "A Three-Line Whip is being issued to all BJP Members in the Lok Sabha and Rajya Sabha from Thursday to Saturday, 16th to 18th April 2026." It further instructed: "All Hon'ble Union Ministers and Members are requested to remain present in the House throughout all the three above-mentioned dates." The notice added, "Presence in the House is mandatory. No leave will be granted. Members are requested to strictly comply with the Whip and ensure their uninterrupted attendance in the House." Mumbai, April 12 : Legendary playback singer Asha Bhosle passed away at the age of 93 in Mumbai on Sunday. The singer was admitted to the Breach Candy Hospital on Saturday. Ashish Shelar, the Culture Minister of Maharashtra made the announcement outside the hospital. Her last rites will be held at Shivaji Park on Monday at 4:00 pm. On Saturday, her granddaughter, Zanai Bhosle had revealed that her grandmother was admitted to the hospital due to

extreme exhaustion and a chest infection. She requested privacy during such times. Dropping a photo with Asha Bhosle on her official Instagram handle, Zanai wrote, "My grandmother, Asha Bhosle due to extreme exhaustion and suffering a chest infection has been admitted to hospital and we request you to value our privacy. ## India rejects China's attempt to rename places, reaffirms Arunachal Pradesh an 'integral and inalienable part'

New Delhi, April 12 : India on Sunday rejected China's "mischievous attempts" to assign fictitious names to places which are part of the country, reiterating that territories, including Arunachal Pradesh, remain an "integral and inalienable part" of it. In response to media queries regarding China giving fictitious names to places, Ministry of External Affairs (MEA) spokesperson Randhir Jaiswal urged China to refrain from actions that cause negativity in bilateral ties and undermine efforts



to create better understanding between Beijing and New Delhi. "These actions (Contd. on pg.2)

In a statement, MEA spokesperson Jaiswal said, "India categorically rejects any mischievous attempts by the Chinese side to assign fictitious names to places which form part of the territory of India. ## Endowments Assistant Commissioner Shanti suspended in disproportionate assets case

By Skyline Staff Reporter Vijayawada, April 12 : The Andhra Pradesh government has suspended an Assistant Commissioner in the Endowments Department following her arrest in a disproportionate assets case. The orders for Kalingiri Shanti's suspension were issued by Commissioner K. Ramchandramohan, official sources said on Sunday. The Anti-Corruption Bureau (ACB) had arrested Shanti on April 7 after



simultaneous raids at premises linked to her. She was found to have amassed assets worth Rs 1.37 crore, disproportion-

ate to her known sources of income. The same day, a court in Vijayawada sent her to judicial custody till April 21. As per the government rules, any employee detained in custody for more than 48 hours on a criminal charge is deemed suspended. ACB officials conducted searches for 10 hours in different locations, including Tadepalli, Undavalli, and Visakhapatnam. (Contd. on pg.2)

## Set for take-off: How Bhogapuram International Airport launch will change Vizag

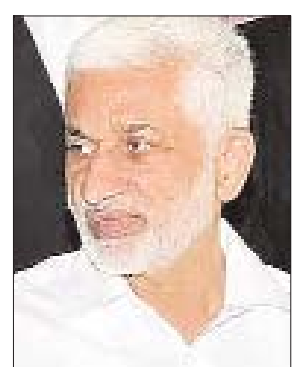
By Skyline Staff Reporter Visakhapatnam, April 12 : The nearly-completed, eagerly-awaited Bhogapuram International Airport is on the verge of its launch. As per the latest headlines, the airport is likely to be inaugurated in July in the presence of Prime Minister Narendra Modi. Envisioned as a key infrastructure anchor, the development is set to be a growth accelerator for nine districts in Andhra Pradesh, transforming regional-global interconnectedness and introducing exciting investment



opportunities to the State. In Visakhapatnam, the launch of the airport means big reforms in connectivity, employment, tourism, and hospitality in the region. Already, seven roads with a budget of Rs 175 crores are being constructed speedily between the districts, with 60% of the works being completed. Anyone using them will be able to reach Bhogapuram in under one hour and thirty minutes. However, even more proposals are in the books to ensure that the Vizag-Bhogapuram track remains seamless and uncongested. VMRDA Chairman Pranav Gopal, in talks with Yo Vizag, said, "The aim is to improve connectivity alongside the employment (Contd. on pg.2)

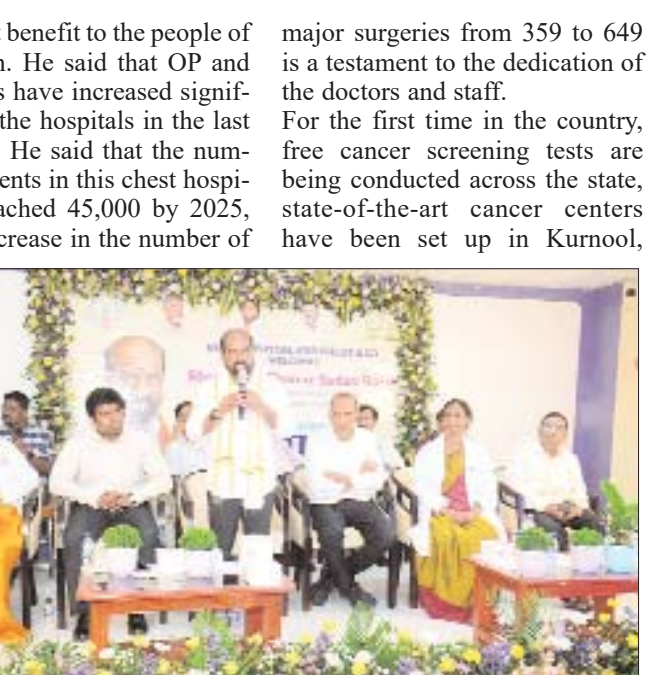


ing with any political party, and aims to serve as a voice of the people. The proposed platform will deliver news in Telugu, English, and

## The government's goal is to protect public health Revolutionary changes in the field of medicine -- Health Minister Satyakumar Yadav

By Skyline Staff Reporter Visakhapatnam, April 12 : The main objective of the government is to bring corporate-level medical services closer to the poor, said Health and Family Welfare Minister Shri Satya Kumar Yadav, adding that the medical sector in the state has achieved remarkable growth in the last two years. On Sunday, the Minister, along with District Collector Abhishek Kishore, inaugurated water fountains along with an endobronchial ultrasound machine (ebus) at the Chest and Communicable Diseases Hospital in Visakhapatnam. Speaking at a gathering organized on this occasion, Minister Satya Kumar Yadav said that this ultrasound mission is the first of its kind in the Telugu states and will



be of great benefit to the people of this region. He said that OP and IP services have increased significantly in the hospitals in the last two years. He said that the number of patients in this chest hospital has reached 45,000 by 2025, and the increase in the number of major surgeries from 359 to 649 is a testament to the dedication of the doctors and staff. For the first time in the country, free cancer screening tests are being conducted across the state, state-of-the-art cancer centers have been set up in Kurnool, Kadapa and Guntur, and by the next financial year, comprehensive cancer centers will also be completed in Kakinada and Anantapur, working towards a cancer-free Andhra Pradesh. He said that funds have been increased drastically under Aarogyasri (NTR Medical Service). He said that the payments, which were previously 6 lakh rupees, have now increased to 3 crore 76 lakhs. Due to this, people's trust in government hospitals and doctors has increased. He said that steps are being taken to ensure that a new dialysis machine is made available in the state every three days. They said that they are increasing the number of dialysis machines from 550 to 725 to (Contd. on pg.2)

# Police Issue Warning Against IPL Betting in Cheepurupalli

Cheepurupalli, April 12  
Acting on the directions of the Superintendent of Police (SP) and under the guidance of the Sub-Divisional Police Officer, strict surveillance has been intensified across Cheepurupalli mandal to curb illegal betting activities during the ongoing IPL matches.

According to police officials, including the Circle Inspector, Sub-Inspectors, and staff, stringent legal action will be taken against individuals involved in organizing, promoting, or participating in IPL betting. Such offenders will also be recorded in police station history sheets.

The police have issued a



strong advisory to the youth, cautioning them against falling into the trap of betting, which could lead to financial losses, damage to family relationships, and loss of social reputation. They urged youngsters to stay away from such illegal activities and focus on building a

stable and respectable future. Officials further revealed that special surveillance is already in place on certain individuals suspected of involvement. If they fail to reform and continue these activities, strict cases will be registered and necessary legal action will be taken.

nation, it is essential that women play a greater and active role in this journey."

Referring to the long-standing debate on women's reservation, the Prime Minister recalled the developments of 2023, when lawmakers across party lines supported the legislation.

"It was a memorable moment that reflected our unity. The entire world witnessed how a major decision was taken collectively to fulfil a commitment to the women of the country. Women represent nearly half of our population, and this was a strong step towards enhancing their participation in the political domain. I consider that day an important and inspiring milestone in India's Parliamentary journey," he said.

PM Modi also noted that several Members of Parliament had contributed to discussions on the issue, including the timing of its implementation. He added that the government had engaged in consultations with experts and political parties before arriving at its current position.

"After extensive deliberations, we have reached the conclusion that the time has now come to implement the Nari Shakti Vandan Adhiniyam in its true spirit across the country. It is imperative that the 2029 Lok Sabha elections and Assembly elections are conducted with women's reservation in place. This will infuse new energy into India's democratic institutions and strengthen public trust. It will also ensure greater participation and representation in governance," he said.

Calling for a united approach, the Prime Minister added, "I am writing this letter so that we may all come together in one voice to pass this amendment. It would be great to have many Members of Parliament express their views on this subject in Parliament. This is a moment above any one party or individual. It is a moment to demonstrate responsibility towards women and our future generations. Since all political parties have expressed the desire to increase women's representation in politics for a long time, this is the right time to turn that aspiration into reality."

Describing the move as a landmark step, he further said, "I have full confidence that we will all come together and achieve this historic feat in Parliament. Members of Parliament who contribute to the implementation of the Nari Shakti Vandan Adhiniyam will always take pride in having been part of this historic effort. Therefore, we must not let this opportunity pass."

"Your support for the amendment to implement the Nari Shakti Vandan Adhiniyam will be the fulfilment of an important responsibility towards the women of our country. Let us further strengthen our great democratic traditions and take decisive steps toward a historic transformation," he added.

The ruling Bharatiya Janata Party will require support from opposition parties to secure the two-thirds majority needed for the passage of the constitutional amendment in Parliament.

The proposed legislation seeks to delink the implementation of women's reservation from the 2027 Census and instead base it on the 2011 Census, in a move aimed at ensuring that the quota comes into effect before the 2029 general elections.

"We have been at it now for 21 hours... we've had a number of substantive discussions with the Iranians. That's the good news. The bad news is that we have not reached an agreement," he said.

Washington, he added, had clearly laid out its negotiating boundaries.

"We've made very clear what our red lines are... and they have chosen not to accept our terms," Vance said.

At the core of the impasse is the US demand for a long-term guarantee that Iran will not pursue nuclear weapons capability.

"We need to see an affirmative commitment that they will not seek a nuclear weapon and they will not seek the tools that would enable 'em to quickly achieve a nuclear weapon," he said. Vance emphasised that Washington is seeking durable assurances, not temporary pledges.

"Do we see a fundamental commitment of will for the Iranians not to develop a nuclear weapon? Not just now, not just two years from now, but for the long term. We haven't seen that yet," he said.

He also highlighted the broader national security coordination behind the negotiations, noting that the team remained in touch with senior officials throughout.

"We obviously also talked to... the entire national security team... because we were negotiating in good faith," Vance said. While declining to disclose specific sticking points, Vance maintained that the US side had shown flexibility.

"I think that we were quite flexible. We were quite accommodating... and unfortunately we weren't able to make any headway," he said.

upcoming legislative agenda, with the government expected to push key business during the special session of Parliament beginning April 16, which will run for three days.

Both the Lok Sabha and Rajya Sabha will reconvene on April 16 after a brief break in the Budget Session. The session is expected to focus on significant legislative proposals, including major reform bills linked to electoral and structural changes in governance.

Lawmakers are also expected to engage in high-stakes discussions that may require full attendance and possible voting, prompting the ruling party to enforce strict discipline through the whip.

The Women's Reservation Bill (Nari Shakti Vandan Adhiniyam), which provides 33 per cent reservation for women in the Lok Sabha and State Assemblies, is expected to be taken up during the upcoming special session of Parliament beginning April 16.

A three-line whip is considered the strongest directive in parliamentary procedure, and violation can lead to serious disciplinary action, including possible disqualification from the party in extreme cases.

The issuance of the whip comes amid heightened political activity in Parliament, where the government is preparing for crucial debates and potential passage of key bills. The opposition is also expected to strongly contest the agenda during the session, making full attendance of ruling party MPs strategically important.

### Asha Bhosle passes away at 93, last rites to be held on Monday

One of the most influential singers of her time, Asha Bhosle, sang her first song as a playback for the 1943 Marathi drama 'Majha Bal'. She is known for lending her voice to some noteworthy numbers such as 'Chura Liya Hai Tumne Jo Dil Ko', 'Do Lafzon Ki Hai Dil Ki Kahani', 'Kya Ghazab Karte Ho Ji', 'O Haseena Zulfoonwale Jane Jahan', and 'Ye Ladka Hay Allah Kaisa Hai Diwana', to name just a few. Along with Hindi, she has sung in around 20 Indian and foreign languages.

In 2006, Asha Bhosle herself disclosed that she has almost 12,000 songs to her credit. During her tenure as a singer spanning several decades, Asha Bhosle has worked with many acclaimed music composers such as Shankar-Jaikishan, RD Burman, OP Nayyar, Ilaiyaraaja, Bappi Lahiri, and AR Rahman. She has received numerous awards throughout her career for many of her noteworthy songs. The singer was given the prestigious Dadasaheb Phalke Award back in 2000, followed by a Padma Vibhushan in 2008.

Consistent with our principled position, we reject such attempts categorically. Creative naming will not alter the undeniable reality that Arunachal Pradesh was, is, and will always remain an integral and inalienable part of India."

He said that threatening to cut out the tongues of media organizations that are writing the facts is strangling the Fourth Estate created by the Constitution. He criticized that even though the people limited the number of seats from 151 to 11, Jagan has not come to his senses and is acting more like a maniac without learning lessons from his mistakes.

Questions rained on Viveka's murder

Minister Nimmala rained questions on Jagan, referring to the Vivekananda Reddy murder case. "Jagan has a history of killing his own father with an axe for politics. Isn't it true that Sonia Gandhi reprimanded you when

you threatened the uncontroversial Viveka to resign from the post of MP?" he questioned.

If Viveka died of an axe attack, why did Sakshi media advertise it as a 'heart attack'? He questioned why he came 12 hours late and was busy erasing evidence if his own younger brother was murdered. Would he try to cover up a murder by stabbing a person anywhere in the world? He was furious. He said that just as witnesses disappeared in the Paritala Ravi murder case, witnesses are being disappeared in the Viveka murder case today as well, and Jagan demanded an answer to this.

Is this the attitude towards family members?

Nimmala said that all the people of the state have seen the way Jagan Reddy treated his family members. He alleged that they would be thrown out of the house just by saying, "My mother, my sister." "Isn't it hypocritical to say that we will do good for the women of the state now?" he asked.

He said that collecting signatures and trying to become the Chief Minister when YS Rajasekhara Reddy died in a helicopter crash and his whereabouts were unknown is a testament to Jagan's perverse mentality. "Father Rajasekhara Reddy himself did not like Jagan's arrival. You should tell him to stay in Bengaluru," Vijayamma herself called Rosaiah garu and pleaded with him, and from this, Jagan's character can be understood. He said that Jagan

has no right to mention Ranga garu's name

Nimmala Ramanaidu strongly criticized Jagan for not having the moral right to talk about Ranga garu. "Jagan has a history of bringing Ranga garu's murderers under his wing. Jagan should tell which party the son of the main accused in the Ranga murder case is in today. Why was land worth crores in Hyderabad gifted to the murderer's family?" he questioned.

He said that honoring Gautham Reddy, who insulted Ranga garu by calling him a 'rowdy', by giving him the post of Fiber Grid Chairman is proof of Jagan's hatred towards Ranga garu. He was furious that he should be ashamed of raising Ranga's name by hanging around with murderous families. Nimmala accused Jagan of becoming an economic terrorist by obstructing his father's power during the political samadhi of the Goddali party, and today he has become a political terrorist and corrupted the state. He said that the damage caused by the YSRCP rule between 2019-24 is greater than the damage caused by the division of the state. He said that to save the state from that destruction, CM Chandrababu, Deputy CM Pawan Kalyan and Prime Minister Modi are taking the state back to its feet with the help of Prime Minister Modi.

He criticized Jagan for trying to create destruction again when the state's economy is in a slump. ### Endowments Assistant Commissioner Shanti suspended in disproportionate assets case

They seized incriminating documents and unearthed assets, including a residential flat in Visakhapatnam, a G 2 building at Kunchanapalli, 776 grams of gold ornaments, nearly 3 kg of silver articles, cash worth Rs 1.15 lakh, bank balances of about Rs 3 lakh, a car, a motorcycle, and electronic gadgets.

Following the searches, the ACB registered a Disproportionate Assets (DA) case against the Assistant Commissioner under the Prevention of Corruption Act. The anti-graft agency took the action following information that she allegedly amassed wealth beyond her known sources of income.

This is the second time that Shanti has been suspended in two years.

She was appointed as Assistant Commissioner in the Endowments Department through the Andhra Pradesh State Public Service Commission (APPSC) in 2020, and worked in Visakhapatnam and Vijayawada.

After the TDP-led coalition government came to power in 2024, Shanti was suspended for over an allegation of irregularities.

She was under suspension from July 2024 to March 2026.

The Endowments Department had initiated a departmental inquiry into the allegations against Shanti. The government had seriously taken the allegations against Shanti, including her recruitment procedure itself.

The suspension was lifted last month, and she was waiting for a posting.

sector. For instance, we have proposed a Ring Road from Atchutapuram to Rambili. For employees who work at ArcelorMittal or Blue Jet Healthcare, this would ease travel." But everyday travellers may stand just as much to gain. "We are considering AC shuttle buses to and from the airport, similar to the network at Rajiv Gandhi International Airport in Hyderabad," the Chairman said.

One of the defining aspects of the Bhogapuram International Airport project is its integration with multiple transport networks. The airport is planned to function as a multi-modal connectivity hub by linking air travel with road, rail, and port infrastructure across the region. Additionally, a proposed coastal corridor is expected to strengthen logistics and north-south mobility along the Andhra Pradesh coastline.

As the airport is expected to boost tourism, the coastal corridor is also set to become a tourist hotspot. "We are acquiring about 40 sq km worth of land on the Kailasagiri-Bheemili stretch to develop as 'Bay City' as the Bhogapuram International Airport brings international tourists to Vizag. In fact, we plan to launch a Trishul on Kailasagiri soon, at a height of 65 meters," added Pranav Gopal.

While serving North Coastal Andhra, the Bhogapuram International Airport is expected to function as a convenient international gateway for neighbouring regions outside the state as well. Parts of South Odisha and southern Chhattisgarh, particularly along the Rajpur-Visakhapatnam corridor, could benefit from the airport's connectivity.

For people living in smaller towns in the region, access to global markets, educational opportunities, and tourism destinations. For travellers and businesses in these areas, Bhogapuram may strengthen cross-border mobility and trade flows. For youth, the airport offers employment opportunities. "The aereocity being built around Bhogapuram is majorly facilitating skill development among unemployed youth. It is also encouraging more IT companies to look at Andhra as a talent pool," the VMRDA Chairman remarked.

The Bhogapuram International Airport project by GMR also aligns with broader policy frameworks aimed at transforming Andhra Pradesh into a major economic growth centre. The state government's Swarna Andhra 2047 vision and NITI Aayog's roadmap for the Visakhapatnam Economic Region (VER) both emphasise infrastructure-led development as a driver of regional prosperity.

Currently on the onset of its big launch, Bhogapuram International Airport plays a key role in this vision by enhancing aviation capacity, spurring industrial progress, and bringing economic reform through real estate investments.

## Low Rate Era

**Primary & Secondary Schooling (K-12)**  
The signal from the Reserve Bank of India is subtle but consequential: India may be settling into an extended phase of relatively low interest rates. This is not the exuberant easing of a crisis response, nor the defensive tightening of an inflation scare. It is something more structural – a reflection of an economy that, for now, appears stable enough to sustain growth without the discipline of high borrowing costs. At first glance, the reasoning is straightforward.

**Inflation remains within the central bank's tolerance band, growth projections remain respectable, and financial transmission from policy rates to bank lending is functioning with reasonable efficiency.** Under Governor Sanjay Malhotra, the RBI is effectively signalling that the traditional triggers for rate hikes are absent. But the deeper implication lies elsewhere. A low-rate environment over the medium to long term suggests that India's economic management is increasingly confident about its internal balance between growth and price stability.

**This confidence is not accidental. It is built on years of fiscal calibration, supply-side interventions, and a more credible monetary policy framework that has, since the adoption of inflation targeting, anchored expectations more firmly.** This also reflects a quiet shift in savings behaviour, as lower deposit returns may push households towards equities, real estate, or alternative assets in search of higher yields. Yet, the RBI's stance is carefully hedged. The emphasis on a "neutral" position is not mere caution; it is an acknowledgment that India's macroeconomic stability is still vulnerable to forces beyond its control.

**The recent volatility in global energy markets, driven by geopolitical tensions in West Asia, underscores how quickly imported inflation can disrupt domestic calculations.** Oil prices, currency pressures, and trade disruptions remain variables that no central bank can fully domesticate. This creates an interesting paradox. Domestically, the case for low rates is strengthening. Globally, the case for caution persists. The result is a policy posture that is accommodative in direction but conservative in commitment. For businesses and investors, this has tangible consequences. Cheap capital, if sustained, lowers the threshold for investment and risk-taking.

**It can revive credit cycles, support infrastructure expansion, and make long-gestation projects more viable.** For households, it sustains affordability in housing and consumption. But there is also a less visible effect: prolonged low rates can dull financial discipline, encouraging leverage and misallocation if not matched by productivity gains. The more strategic reading, therefore, is not that low rates are guaranteed, but that they are increasingly the baseline ~ subject to interruption rather than reversal. The RBI is not promising cheap money; it is signalling that, barring external shocks, India no longer needs expensive money to keep its economy in check. That distinction matters. It marks a shift from crisis management to structural confidence. Whether that confidence proves durable will depend less on domestic policy and more on how the world beyond India's borders behaves.

Sassy, bold, seductive, playful, haunting, grieving, and soulful, Asha Bhosle could mould her voice in every way possible. Always the one to take the road not taken, she could do it all and be all.

On April 12, the voice that entertained generations of music lovers fell silent.

Asha Bhosle died on Sunday at Mumbai's Breach Candy Hospital following multiple organ failure.

Asha Bhosle was born on September 8, 1933 in Sangli, Maharashtra, to renowned singer Deenanath Mangeshkar and Shevanti Mangeshkar. Asha Bhosle was the third child of the couple, younger to melody queen Lata Mangeshkar and Meena Khadikar, and elder to Usha Mangeshkar and Hridayanath Mangeshkar.

After their father died when Asha Bhosle was just nine, she and Lata Mangeshkar had to start working.

Asha Bhosle, who made her singing debut at the age of 10 with the song Chala Chala Nav Bala for the 1943 Marathi film Majha Bal, initially struggled to find her footing in the film industry, especially when Lata Mangeshkar was the first choice to playback for heroines.

If Lata Mangeshkar was 'Lata Didi', Asha Bhosle was 'Asha Tai'. She was pretty much the antithesis of what Lata Mangeshkar was not.

If Lata Mangeshkar voiced the morally-upright, 'pure' leading lady, Asha Bhosle broke new ground by churning out foot-tapping dance numbers featuring the vamp or the 'item girl' performing cabaret at a club.

If not for Asha Bhosle, Helen would never have had a voice. O Haseena Zulfonwari, Aa Jaane Jaan, to Ye Mera Dil, it is impossible to imagine Helen's sultry dance moves without Asha Bhosle's vigour and passion.

And, Asha Bhosle knew she had to do something unique to be able to carve her own niche in showbiz. If she could make you groove to Jawani Jaaneman and Dum Maaro Dum, she could make you miss your beloved with Jaaoon Kahan Jaaoon and Ye Kya Jagan Hai Doston. Chura Liya Hai Tumne Jo Dil Ko, Piya Tu Ab To Aaja, Abhi Na Jao Chhod Kar, In Ankhon Ki Masti, Aage Bhi Jaane Na Tu, to Ek Main Aur Ek Tu, the range she displayed in the love song genre alone was phenomenal.

"I thought to myself, if I will continue to sing in a similar voice to didi, then I will never get work as long as didi is in the business. I won't have a name and fame of my own. After this incident, I began to change my style of singing."

"I started to watch English movies to learn Western songs, observe how they would sing in English. I also learnt how to sing qawwali, ghazals, the voice modulations needed in different forms of singing. I started to learn it all," Asha Bhosle once said.

There were many comparisons and a lot of speculation about sibling rivalry, one that neither confirmed.

"People did carry tales and try to create trouble, but blood is thicker than water. I remember, sometimes both of us would be at a function and some industry types would ignore me and interact only with her, as if to prove their loyalty. Later, Didi and I would have a good laugh," Asha Bhosle had said.

Sai Paranjpye's 1998 film Saaz was reportedly based on the professional tussel between Asha Bhosle and Lata Mangeshkar, a claim the former rubbished. "It's not true at all. To have two women in long plaits, take a couple of incidents and exaggerate them into a three-hour film is such a waste of time," Asha Bhosle had said.

She eventually went on to create her own space, independent of her elder sister Lata Mangeshkar. Initially pegged as the dance number voice, Asha Bhosle loved challenges and loved proving people wrong.

During the photo installation ceremony of her late sister Lata Mangeshkar at Deenanath Mangeshkar Natyamandir Hall in Mumbai, Asha Bhosle broke down remembering her 'Didi' a few years after her death.

"She used to say, 'My blessings are always with you whether you come here or not. Mai, Baba and I are always there for you.' Now after her, whose blessings should I seek? Whom should I tell my troubles? We all have become orphans. She should have been with us guiding us for at least a few more years," she recalled.

After Asha Parekh, Sadhana, Rekha, the 62-year-old Asha Bhosle sang for Urmila Matondkar, 21 at the time, in Rangleela. She also gave chartbusters for 90s stars Aishwarya Rai Bachchan, Karisma Kapoor, and Shamita Shetty.

Even in her twilight years, Asha Bhosle -- whose X bio read: "Singer since 1943" -- was never complacent. "No one is complete. It is always about how you can change or evolve with time. I've sung songs for the main artist and for the dancers as well.

shimmering pink saree and her signature pearl bracelet with glittering tassels, a jewellery piece that was a constant at all her live shows.

She commanded the orchestra like the boss lady she was with her unconventional voice that still holds sway over music lovers.

Asha Bhosle also tried her hand at indipop in the late 1990s and early 2000s, with several remixes of her songs such as Parde Mein Rehne Do, a move for which she courted criticism. But she gave banger such as Jaanam Samjha Karo with Leslie Lewis.

In 2006, she released Asha and Friends, singing duets, with Sanjay Dutt and Urmila Matondkar and former Australian cricketer Brett Lee, with whom she sang, You're the One for Me (Haan Main Tumhara Hoon). She was 78 when she her acting debut with the Hindi film Mai in 2012.

Just six years ago, Asha Bhosle made her YouTube debut with the single Main Hoon, dedicated to spiritual guru Sri Sri Ravi Shankar.

Asha Bhosle, by her own admission, was "the last Mughal of this film line."

In 2023, the singer said, "If you look at the history of the film industry, only I know about it. I know the life of every person - directors, producers, artists, singers, everyone. If I start talking, it will take me three-four days. There are so many stories, I have not forgotten anything. I am the last Mughal of this film line."

I believe I could fit in well with anyone. But I wish I had sung more songs in different languages. I wish I could have done more classical singing," said the late singer, who was recognised by the Guinness Book of World Records as the most recorded artist in music history in 2011.

Asha Bhosle, who sang over 12,000 songs in as many as 20 languages, formed key partnerships with music composers, including OP Nayyar, SD Burman, RD Burman, whom she later married, Bappi Lahiri, and AR Rahman. A firm believer in destiny, the singer was also vocal about facing politics in her heyday.

"In every field, there's politics. In films too there's politics, so it is not easy. I believe a lot in destiny and I believe whatever is meant for me will come to me and what is not meant for me, I'll never get that. I faced difficulties but today when I look back, it all looks mazedar (fun) as I came out of it," she told PTI ahead of her live concert in Dubai to mark her 90th birthday.

Yet life brought its fair share of troubles. Asha Bhosle was just 16 when she eloped with her personal secretary, Ganpatrao Bhosle, and had three children with him. After enduring years of mistreatment from her husband and in-laws, she separated from him in 1960. She remarried her frequent collaborator RD Burman in 1980; they had no children.

There's a faint memory of watching Asha Bhosle live in concert on television in the early 2000s. She wore this

## Ahead of Bengal polls, decoding the Bhadraklok's views on SIR

In Kolkata's social vocabulary, a particular group has long held a special place - the 'bhadralok', or what is often referred to as the 'madhyabitta' (middle-class). In English-language discourse, this social class was once described as the "middling class", and the term later evolved into the "educated middle class", sometimes simply called the "middle class".

During the colonial period, British officials, who first encountered this social group, referred to them as "educated natives." Like most modern social classes, however, the boundaries of the bhadralok community are difficult to define precisely.

In West Bengal, and particularly in Kolkata, the bhadralok have historically played a central role in shaping public opinion.

In earlier decades, the Congress party enjoyed considerable support among Kolkata's urban middle class, while rural Bengal leaned more towards the Left parties. Later, during the final phase of Left rule, Buddhadeb Bhattacharjee maintained significant support among urban educated voters, while Mamata Banerjee emerged as the political favourite in rural Bengal.

Eventually, Banerjee managed to expand her influence across both demographics.

However, in the 2026 Assembly election, a different pattern appears to be emerging in parts of urban Kolkata. In some areas, there is visible anti-incumbency after nearly fifteen years of Banerjee's government. Among

sections of the bhadralok, too, a certain level of dissatisfaction has become evident.

Their concerns revolve around several issues that have dominated political debates in the state, including the education recruitment scam, allegations of corruption in political campaigns, and the activities of the so-called "syndicate" networks involved in construction and local contracting. For many members of the Bengali bhadralok community, these controversies have created a sense of disillusionment with the present administration.

The Special Intensive Revision (SIR) of the voter list has added another layer of controversy. Some argue that the deletions disproportionately affect slum residents or minority communities in Kolkata, while others suggest that the exercise targeted illegal infiltrators, including Bangladeshis living in railway colonies or old refugee settlements.

Differing Opinions  
Renowned filmmaker Arindam Sil said, "We are not against SIR, but we are worried about the abrupt huge deletion. Bengali cultural degradation is a wrong perception because there are good films Bengalis are still creating. Tagore's songs, dance and book fairs -- all are still happening. But deleted voters can't get hearings from tribunals. This is unthinkable."

Painter and renowned artist Samir Aich disagreed. "After the RG Kar and Sandeshkhali incidents, Bengali

culture has completely eroded. I do not subscribe to any particular party but, as a creative person, I think Bengal has lost its cultural glory in the past 15 years. Vote bank politics should be stopped. The SIR idea is good," he said.

Retired police officer Nazrul Islam also said implementing the SIR was a good decision and that the Trinamool Congress government in the state had "destroyed" the state's development model.

Banerjee and the Trinamool have argued that many genuine voters have been removed from the list and that the deletions do not affect only minority communities, but also a significant number of Hindu voters.

There have been several reported instances where academicians, teachers, professors, college students, and government employees discovered that their names were missing from the voter lists. For many people, the

process of correcting the records and re-entering their names has proven to be complicated. The SIR verification procedure requires filling out multiple forms and appearing for inquiries, which many citizens have found difficult and stressful.

The BJP has tried to counter these criticisms by arguing that voter list revisions have taken place in several other states as well, including Kerala, Assam and Tamil Nadu, without similar political turmoil. The party says the protests in West Bengal are largely incited by the Trinamool.

Banerjee, however, has argued that there is a political conspiracy behind the process, claiming that it is being used as a method to remove voters sympathetic to her party. In her campaign speeches, she accused the Election Commission of functioning as a political instrument of the BJP, an accusation that the saffron party has denied.

Voices Raised  
As a result, two parallel currents are now visible in Kolkata's public discourse. On the one hand, there is genuine discontent among sections of the bhadralok community regarding governance issues. Many of these voices regularly appear in television debates and discussions across social media platforms. Among sections of the Bengali middle class, criticism of the government has been growing.

However, the SIR controversy has also caused discomfort among several independent intellectuals and professionals who do not align with the Trinamool Congress. For example, Dr Kunal Sarkar, a well-known cardiologist, and Professor Sukanta Chowdhury, emeritus professor of Jadavpur University, have expressed concerns about the way the process has been handled. These figures are generally regarded as free-thinking public intellectuals rather than supporters of any particular political party, yet they have voiced dissatisfaction with how the Election Commission and judicial officers conducted the SIR process.

Sarkar said, "It is terrible. The BJP should not advance its political interests through the Election Commission and SIR."

In the end, how all these factors will influence the final electoral outcome remains uncertain. As the saying goes, the final word will only be known when the results are declared.

## They came. They talked. What next and where does this leave Pakistan?

The bad news is the highest level talks between the US and Iran in nearly five decades ended without a deal, which seemed a heavy lift even for the most optimistic. Washington has made its last and final offer, though with US President Donald Trump it is never clear if last really means last, or final really means final. Even as the talks were underway Trump seemed uninterested in the outcome saying a deal "doesn't even matter because the US has already won." It is a fool's mission to read anything into Trump's utterings, but given the unpopularity of the Iran war in America and the president's nosediving poll numbers, it may be that he has lost his appetite for the war and simply declares victory. Unsurprisingly the sticking points to a deal remain the fate of the Strait of Hormuz and Iran's nuclear ambitions, both for its domestic energy needs and possible future use for weapons production, something Tehran has consistently insisted it is not seeking. Iran also wants an end to Israel's assault on Lebanon, which unsurprisingly Israel has refused, even as Washington seeks to broker a cease fire between the Middle Eastern neighbors. Where does this now leave Pakistan? Pakistan has been walking an increasingly wobbly tightrope leveraging its military strength and its friendship with both its neighbors and the United States to get the two-week cease fire agreement and significantly a historic face-to-face

meeting between Washington and Tehran. That feat alone has been monumental and it still might pay off with a final agreement. The stakes, however, are high for Pakistan which has put a lot on the line to broker these talks. While its international reputation has soared, a resumption of the war could drag Pakistan, which leveraged its military strength to get folks to the table, into the war. Even as Pakistan was basking in the glow of having orchestrated the talks and was working the American and Iranian delegations to get an agreement, Islamabad was deploying its forces to Saudi Arabia. The deployment reinforces its security alliance with Saudi Arabia and risks drawing Pakistan into the war if renewed fighting brings renewed attacks by Iran on Saudi Arabia. The troop deployment was announced at the start of talks and by Saudi Arabia, not Pakistan, both of which seem significant and would seem a message to Iran and to its Houthi allies in Yemen that a resumption of the war will mean they will have to answer to Pakistan as well as Saudi Arabia. Effectively Saudi Arabia has activated its Strategic Mutual Defense Agreement with Pakistan. According to the Saudi Foreign Ministry announcement "The

Pakistani force consists of fighter and support aircraft belonging to the Pakistani Air Force, with the aim of enhancing joint military coordination, raising the level of operational readiness between the armed forces of the two countries, and supporting security and stability at both regional and international levels." The last major assault by Iran on its neighbors prior to the two-week cease fire agreement was against

Saudi Arabia. On April 7 and 8 a barrage of Iranian missiles and drones hit the Jubail Industrial hub, including the large Sadra complex. The attack hit Saudi Arabia's critical east-west crude oil pipeline, its key export route, striking at the heart of the kingdom's petrochemical industry. Even as Saudi Arabia intercepted several of the Iranian missiles the damage was extensive and reportedly cut Saudi oil production by 600,000 barrels a day. Saudi Arabia has now activated its security agreement with Pakistan and that means if the war resumes and Iran again attacks Saudi Arabia, Pakistan will be obliged to enter the war. Pakistan's air force demonstrated its prowess last May during a brief four-day war with neighbor India downing as many as five Indian aircraft, including three French made Rafale fighter jets before declaring itself the winner of the war. Trump who took credit for brokering the cease fire between the nuclear armed South Asian neighbors also declared Pakistan the winner. A resumption of the Iran war risks again testing Pakistan's air force and dangerously escalating the war, something it is hoped Iran would not want to see. Pakistan's strategic defense pact with Saudi Arabia may turn out to be the greatest bargaining chip or the deadliest.

## Iran says talks marked by 'mistrust, suspicion'; breakthrough wasn't expected in single round

Acknowledging the absence of a breakthrough in the latest round of negotiations with the United States, Iran on Sunday said the talks were held in an atmosphere of "mistrust and suspicion," with no realistic expectation of reaching a comprehensive agreement in a single session. Foreign Ministry spokesperson Esmail Baghaei said the two sides were able to arrive at an understanding on several issues, but critical differences persisted. "We reached understanding on a number of points, but key disagreements remained on two to three major issues, and ultimately the talks did not lead to an agreement," he said. Baghaei described the negotiations as the longest in the past year, stretching over 24 to 25 hours of continuous engagement—an indication of both the complexity of the issues and the intensity of the discussions. He stressed that the context of the talks made a swift resolution unlikely. "These discussions took place after 40 days of imposed war, in an at-



mosphere of mistrust and suspicion," he said, adding that under such conditions, "no one expected an agreement to be reached in a single session—and no one did." The remarks underscore Tehran's attempt to frame the outcome not as a failure, but as part of a broader, incremental process shaped by deep-seated distrust and recent conflict. While no deal emerged, the acknowledgement of limited convergence on certain issues suggests that negotiations may continue, even as fundamental differences remain unresolved.

## Cyclone lashes New Zealand's North Island, hundreds evacuated

A cyclone battered New Zealand's North Island on Sunday, cutting power to thousands of residents and forcing hundreds to evacuate, as officials warned conditions would worsen through the day. The cyclone was tracking "more towards the fringes" of the North Island, sparing Auckland — the country's most populous city — from the worst conditions, Emergency Management Minister Mark Mitchell said. But stronger winds and swells were still expected when it crossed the coast. "It's moved more to the fringes and

more to the east, which means that we haven't quite seen the intensity that we had prepared for or that we thought we were going to get hit with. So that is good news," Mitchell said. "In terms of what we're going to expect over the next 12 hours is we are going to see a bit more of intensification, as the cyclone starts to come down and get closer." The combination of the afternoon's high tide and large swells from the storm could trigger coastal inundation, Mitchell warned. "The concerning time is really from 2 pm this afternoon onwards when we've got high tides combined with those big swells," he said. The cyclone has forced hundreds of residents to evacuate and knocked out electricity to some 5,000 homes so far, with power restored to roughly 2,000, he



said. New Zealand Defence Force members and heavy equipment have also been deployed to assist with evacuations. MetService said it had recorded wind gusts of over 130 kph in some areas and 24-hour rainfall totals of over 100 mm (3.9 inches) in the city of Whangarei. Vaianu has conjured up memories of 2023's Cyclone Gabrielle, which killed 11 and displaced thousands in one of New Zealand's biggest natural disasters this century.

## China offers incentives to Taiwan following opposition leader's visit

China on Sunday unveiled 10 new incentive measures for Taiwan, including easing tourist curbs, allowing in "healthy" television dramas and facilitating food sales, following a visit by the island's opposition leader. The move comes at the end of a trip to China by Cheng Li-wun, chairwoman of the Kuomintang (KMT), Taiwan's largest opposition party. She met Chinese President Xi Jinping and talked about the need for peace and reconciliation. The 10 measures, unveiled by the official Xinhua news agency, "explore" the establishment of a regular communication mechanism between the KMT and China's Communist Party, the full resumption of flights between the two sides and permission for individuals from Shanghai and Fujian province to visit Taiwan. A mechanism will be established to ease inspection standards for food and fish-



ery products, but that has to be on the political foundation of "opposing Taiwan independence", Xinhua said. Taiwanese TV dramas, documentaries and animation will be allowed to be shown as long as they have "correct orientation, healthy content, and high production quality", it added. There

was no immediate reaction from Taiwan's government. China refuses to talk to Taiwan President Lai Ching-te, saying he is a "separatist". He rejects Beijing's sovereignty claims over the democratically governed island. China and Taiwan have blamed each other for the lack of a resumption of

large-scale Chinese tourism to the island since the end of the Covid-19 pandemic. Taiwan has also previously complained about Chinese restrictions on imports of certain agricultural and aquatic products, saying China has in some cases used unjustified excuses to stop the spread of pests and diseases.

## US-Iran talks collapse in Islamabad; Vance returns without deal

High-stakes negotiations between the United States and Iran ended without a breakthrough in Islamabad on Sunday, as US Vice President JD Vance departed for Washington after 24 hours of intensive talks mediated by Pakistan. Addressing a press conference in Islamabad, Vance acknowledged limited progress but confirmed that the two sides had failed to bridge core differences. "We've had a number of substantive discussions with the Iranians. That's the good news. The bad news is that we have not reached an agreement, and I think that's bad news for Iran much more than it's bad news for the United States," he said. Vance said Washington had clearly outlined its "red lines" and areas of possible compromise, but Tehran declined to accept the terms. At the heart of the impasse, he emphasised, was the US demand for a long-term, verifiable commitment that Iran would neither pursue nuclear weapons nor develop the



capability to rapidly produce them. "The simple fact is that we need to see an affirmative commitment—not just for now, not just for two years, but for a very long period of time," he said. Vance added that while Iran's previous enrichment infrastructure had been dismantled, the question of intent remained unresolved. "Do we see a fundamental commitment of will from the Iranians?" he asked, underscoring what he described as the central objective of the negotiations. Despite the deadlock, Vance said the United States had left behind what he termed its "final and best offer,"

leaving the door open for Tehran to reconsider. On the other side, Iranian officials struck a defiant yet measured tone. Esmail Baqaei, spokesperson for Iran's Ministry of Foreign Affairs, described the talks as "intensive" and "wide-ranging," covering issues from the nuclear programme to sanctions relief, war reparations, and regional security, including the Strait of Hormuz. Baqaei said Iran's delegation had worked "without interruption" and remained committed to defending national interests. "The Islamic Republic of Iran is determined to

utilise all tools, including diplomacy, to secure national interests and protect the country's well-being," he said. Baqaei also signalled that progress would depend on Washington's approach. "The success of this diplomatic process depends on the seriousness and good faith of the opposing side," he noted, warning against "excessive demands and unlawful requests." The spokesperson reiterated Iran's stance on safeguarding its sovereign rights, adding that recent national losses had only strengthened Tehran's resolve. Both sides expressed gratitude to Pakistan for hosting and mediating the talks, though the failure to secure even a preliminary agreement underscores the deep mistrust that continues to define US-Iran relations. With Washington returning empty-handed and Tehran holding firm, the prospects for a near-term diplomatic breakthrough remain uncertain, even as both sides leave the door ajar for future engagement.

## Jaishankar begins UAE visit; Goyal holds talks with Saudi counterpart

External Affairs Minister S Jaishankar on Sunday began his visit to the UAE, while Commerce Minister Piyush Goyal held a virtual meeting with his Saudi Arabian counterpart Majid bin Abdullah al-Qasabi. "We discussed strengthening India-Saudi Arabia trade relations, enhancing energy supply cooperation and advancing negotiations for a trade agreement between India and GCC (Gulf Cooperation Council) countries," Goyal said. Jaishankar said he began his visit by interacting with members of the Indian community. "Spoke about the Government of India's efforts towards their well-being and security amidst the West Asia conflict," he said. He appreciated the contributions of the Indian community to local society during these difficult times, as well as the support of the UAE government in ensuring their welfare. Meanwhile, Minister of Ports, Shipping and Waterways Sarbananda Sonowal posted on X



that another Indian-flagged vessel, 'Jag Vikram', navigated by 24 Indian crew members, successfully sailed out of the Persian Gulf region on April 11 carrying LPG. A day earlier, Sonowal had chaired a review meeting on port operations with senior ministry officials amid prevailing West Asia tensions. The minister also directed the Directorate General of Shipping (DGS) to ensure transparency in shipping-related charges and reviewed grievance redressal mechanisms at ports, with instruc-

tions to strengthen them. He had said that India's major ports had cleared nearly 90 per cent of their cargo backlog. Indian ports have undertaken measures such as ground rent waivers, billing concessions, discounts on reefer charges and optimal yard utilisation to ease congestion and support trade, he had said. Major ports, including Deendayal Port, Jawaharlal Nehru Port, New Mangalore Port and Mumbai Port, have largely cleared their cargo backlog. A series of operational measures, increased yard capacities and improved logistics planning are said to have played a crucial role in achieving this. This comes as the Strait of Hormuz remains uncertain amid a fragile two-week ceasefire between Iran and US-Israel forces. The strait, which accounts for about 20 per cent of the world's energy exports, continues to see reduced traffic, though marginally higher than levels before the ceasefire.

## India-UK free trade pact may come into force from second week of May: Official

The India-UK free trade agreement, signed in July last year, is likely to come into force from the second week of May, according to an official. India and the UK, on July 24, 2025, signed the Comprehensive Economic and Trade Agreement (CETA), under which 99 per cent of Indian exports will enter the British market at zero duty, while tariffs on British products, such as cars and whisky, will be reduced in India. "We are expecting the pact to be implemented from the second week of May," the official said. The two countries have also signed the Double Contributions Convention (DCC) pact to ensure temporary

workers would not have to duplicate social levies in either country. The official said that both pacts are likely to be implemented in parallel. CETA aims to double the USD 56 billion trade between the two economies by 2030. While India has opened its market to various consumer goods, including chocolates, biscuits and cosmetics, it will gain greater access to export products, such as textiles, footwear, gems and jewellery, sports goods, and toys. Under the pact, tariffs on Scotch whisky will be reduced from 150 per cent to 75 per cent immediately, and further lowered to 40 per cent by 2035. On automobiles, India will



reduce import duties to 10 per cent over five years, down from the current rate of up to 110 per cent, under a gradually liberalised quota system. In return, Indian manufacturers will gain access to the UK market for electric and hybrid vehicles within a quota framework.

At the time it was announced, the film instantly raised expectations because of the combination of Pradeep Ranganathan, Vignesh Shivan and Anirudh Ravichander.

The expectations further increased when the team released the song 'Dheema Dheema', a few months ago. After getting postponed a few times for reasons best known to the makers, the film was finally released in theatres today. Did, Pradeep Ranganathan, score a fourth hit in a row as the lead actor? Did the director, Vignesh Shivan, come up with an engaging romantic comedy film? Did Anirudh Ravichander's music help the film become a hit? How did Pradeep and Krithi Shetty's pairing look on screen? Did, S. J. Suryah, excel in an antagonist role yet again? Let's figure it out with a detailed analysis.

## What is it about?

What happens when a guy (Pradeep Ranganathan), who doesn't even use a mobile phone in the year 2040, falls in love with a girl (Krithi Shetty), who is a social media influencer and depends on social networking platforms to find her a right match, is the storyline of the film. ## Performances:

Pradeep Ranganathan did well in parts. After a point during the filming, it looked like he lost interest in the project. The lack of interest in him was to be seen at many places in the film where he just appeared blank and bland. S. J. Suryah is the only actor who has appeared totally involved. He did a decent job with his performance and entertained in a couple of sequences with his dialogue modulation. Senior actor, Anandaraj, with his comedy timing, generated a few laughs at a couple of places.

Yogi Babu generated a few laughs but his character irritates after a point. Krithi Shetty in the lead actress role looked good but her performance should have been better. However, it is unfair to blame her for not coming up with a good performance in a poorly written and executed role. Same goes with the remaining actors in the film. Almost everyone appeared lost and uninterested.

## Technicalities:

Anirudh is known for taking the films to the next level with his music. But in LIK, barring one song, his songs and background score are underwhelming to say the least. Born in 1933 in the princely state of Sangli ( now Maharashtra), she started her singing career with the help of her sister Latha Mangeshkar at a tender age to support her family. She made her singing debut in 1943 with Marathi film Majha Bal. Later, she made her entry into Bollywood in 1948. At the age of 16, she married Ganpatrao Bhosle. She later married composer Rahul Dev.

Though Asha Bhosle initially inclined towards singing fast paced dance numbers of Bollywood,



she later diversified her talent by giving vocals to ghazals, traditional songs, pop music, folk songs, classical numbers and devotional bhajans. She even made her acting debut in 2013 with Mai. For her stupendous contribution to the field of cine-

ma, Asha Bhosle was rewarded with the prestigious Dada Saheb Phalke award by the government of India in 2000. She also become the first Indian singer to be nominated for the coveted Grammy Award in 1997. She was honoured with the much

revered Padma Vibhushan for her illuminating career. Asha Bhosle was officially acknowledged by the Guinness Book of World Records for recording most number of songs in its history. She also featured in BBC list of 100 inspiring women in 2015 and holds numerous doctorates from various universities. She was the recipient of several Filmfare Awards and two time National Awards for her works.

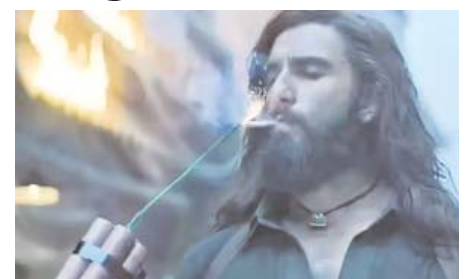

## Badminton Asia Championships: Ayush Shetty loses to Shi Yu, wraps up sensational campaign with silver medal

Shuttler Ayush Shetty's incredible run at the Badminton Asia Championships culminated in a runners-up finish after the Indian fell in straight games to second-seeded Shi Yu Qi of China in the men's singles summit clash here on Sunday. The 20-year-old Indian, ranked 25th in the world rankings, suffered an 8-21, 10-21 loss against the reigning world champion Yu Qi in the final here at the Ningbo Olympic Center.

With his silver medal finish, Ayush became the first Indian men's singles player since HS Prannoy in 2018 to earn a podium finish at the continental championship.

Ayush's win over defending champion Kunlavut



Vitidsarn of Thailand in the semifinal made him just the second Indian men's singles player, and third overall, to enter the Badminton Asia Championships final. A win in the final would have seen him emulate Dinesh Khanna, who became men's singles champion in 1965. Hailing from the small town of Sanoor near Karkala in

Karnataka, the 2025 US Open champion Ayush had a fairytale campaign, as he had registered major upsets in the tournament enroute to the final. His giant-killing spree began in the opening round, where he stunned world No. 7 and reigning Asian Games champion Li Shi Feng of China. He followed it up with a composed win over Chinese

Taipei's Chi Yu Jen, ranked 20th, to book a quarter-final berth, where he delivered another statement performance by topping Olympian and world No. 4 Jonatan Christie of Indonesia before knocking out world No. 1 Kunlavut Vitidsarn in the semifinal. In the women's singles final, Korean star An Se-young defeated Wang Zhiyi 21-12, 17-12, 21-18 to win that one trophy she had yet to win among the major championships. An, 24, Se Young became the first female singles player to cap a career sweep of badminton's majors - the Olympic Games, world championships, World Tour Finals, All England Open, Asian Games and now the Asian Championships.

## Arjun, Aditya clinch India's first gold at US Open Pickleball Championship

Arjun Singh and Aditya Singh secured India's first gold medal at the ongoing US Open Pickleball Championship 2026, defeating top seeds Ryder Brown and Soli Messiri in straight sets in the U-18 boys' doubles category in Naples, Florida. The Indian pair dominated the final, registering an emphatic 11-1, 11-5 victory to outclass the favourites and clinch the title in their maiden appearance at the tournament.

In the women's singles category, Naga Moksha added to India's tally by winning a bronze medal after a closely contested match.

"This is extremely special for us; achieving this together is something that we and our family will cherish for a long time. We have worked very hard to make this happen and thank everyone who have supported us from back home. Most importantly, we are really

grateful to the Maharashtra Pickleball Association and the Indian Pickleball Association for this opportunity."

Arjun Singh & Aditya Singh said right after winning the gold at the championship. The 2026 edition marks India's first participation at the US Open Pickleball Championship under the affiliation of the Indian Pickleball Association (IPA).

## Rs. 87 Lakh Cash Meant for ATM Loading Misappropriated Bank Officials Detect Fraud by CMS Employee

## Inter-state gold shop thief held

The district police have solved a jewelry shop robbery that took place in Sullurupeta and arrested an interstate thief with a long criminal history. They also recovered 12 gold chains weighing 112 grams, valued at Rs 14 lakh, and the scooter used in the crime.

According to police, the accused entered Sri Venkateswara Jewellers in Sullurupeta on March 14 in the guise of buying gold chains, threw chili powder into the owner's eyes, and escaped with 12 gold chains. District SP L Subba Rayudu ordered a special investigation. The probe was led by district crime Additional SP A Srinivasulu and Naidupeta DSP G Chenchu Babu, with special teams formed under the supervision of Sullurupeta CI M Murali Krishna and other officers. Based on the information gathered by the teams, police detained Velmurugan Babu (Pulsar Babu) (35), a resident of Kumaran Nagar, Thondiarpeta, Chennai. During interrogation, he confessed to the crime. Officials informed that the accused has a criminal record of about 10 years and involved in 24 cases in Tamil Nadu and Tirupati district, including Puttur and Srikalahasti, with several NBWs pending against him.

## Demand for Early Construction of Ongole-Bestavaripeta Four-Lane Road and Western Bypass

Ongole April 12, 2026: A strong appeal has been made to Union Minister for Road Transport and Highways Nitin Gadkari to expedite the construction of the long-pending four-lane road from Ongole to Bestavaripeta, along with a western bypass road, on the lines of other national highways. People of the erstwhile Prakasam district have been waiting for nearly 25 years for the development of this crucial road. Despite repeated assurances from political parties, ministers, Members of Parliament, and leaders over the years, the project has not progressed significantly. The delay has resulted in numerous road accidents, leading to loss of lives, including students, and leaving many families devastated. The Ongole-Bestavaripeta stretch

spans approximately 107 kilometers, with nearly 21,000 vehicles plying daily. Despite such heavy traffic, the road has not been fully developed to national highway standards. The region is also known for its granite industry, particularly in Chimakurthy, which contributes significantly to government revenues through GST. Thousands of heavy vehicles, including tippers transporting granite and construction materials, use this route increasing the risk of accidents. Several tragic incidents have highlighted the urgency of road expansion. In one such incident in 2016, an engineering student lost her life after being hit by a speeding granite tipper. The accident, captured on video, shocked the public and briefly drew attention from authorities,

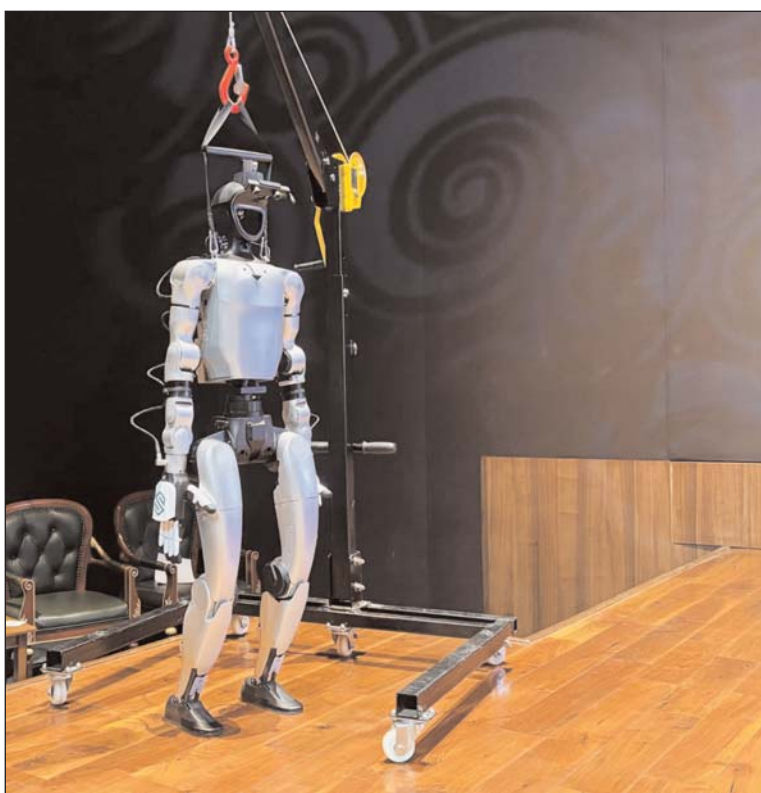


leading to partial development work. However, comprehensive road expansion remains incomplete. Public representatives, including MP Magunta Srinivasulu Reddy, MLA Damacharla Janardhana Rao, and others have brought the issue to the attention of the central and state governments. Chief Minister

N. Chandrababu Naidu has also been urged to intervene. Citizens are now demanding immediate action to complete the four-lane road up to Bestavaripeta and construct the western bypass without further delay, to prevent more accidents and ensure safe travel for thousands of daily commuters.

Even before these incidents subsided, a video involving an Assistant Sub-Inspector (ASI) in an alleged scandal went viral, further intensifying concerns. Officials and staff have expressed anguish that the department's image is being severely affected by such incidents within a short period of time.
